## Welcome to the April Edition of the IFEH Newsletter. At the time of writing European countries are experiencing disclosure problems associated horsemeat found in meat products.

Since the middle of January, when the Food Safety Authority of Ireland published the findings of a targeted study examining the authenticity of a number of beef burger, beef meal and salami products available from retail outlets in Ireland. The study which tested for the presence of horse and pig DNA, revealed the presence of horse DNA in some beef burger products. Since the study results were published Food Safety/Food Standards organisations around Europe have been on high alert. At the beginning of February the UK the Food Standards Agency announced that it now requires a more robust response from the food industry in order to demonstrate that the food it sells and serves is as indicated on the label, and required food businesses to conduct authenticity tests on all beef products. such as beef burgers, meatballs and lasagne and provide the results to the FSA. The tests will be for the presence of horse meat. Many products have now tested positive, not only for the presence of horsemeat but also for pig DNA. Whatever the outcome of the various investigations, and perhaps in the fullness of time prosecutions, the effect on consumer confidence from these incidents is incalculable.

#### IFEH

The next meeting of the IFEH Council will be held on the 18 and 19 May 2013, in the Glynhill Hotel, Renfrew, Scotland. The hotel is situated close to the Glasgow Airport which is about eight miles west of the city centre and just two minutes from the nearest towns, Renfrew and Paisley. Taxis pick up outside the terminal for travel to the hotel. For those travelling by rail the nearest rail station is Paisley Gilmour Street, and again taxis are available for onward travel to the Conference venue. The Council will meet on Saturday 18 May and the Annual General Meeting will take place on the morning of Sunday 19 May. Delegates attending these meetings may also wish to consider registering as delegates for the REHIS Annual Conference which takes place in the same venue on the two days prior to the IFEH meetings.

## Alliance for Healthy Cities Global Conference

The 5th Alliance for Healthy Cities Global Conference "Healthy Urbanisation: Healthy People — Healthy Communities" was held on the 24, 25 and 27 October 2012 in Brisbane, Australia, organised by Alliance for Healthy Cities Australian Chapter and Word Health Organization Western Pacific Regional Office.



The Conference attracted 450 people from 23 countries, mainly from the Asia and Pacific Region, but also from Europe, UK, Brazil, Mexico, Canada and USA. The relevant issues for better leadership of healthy cities were presented and discussed by participants, such as empowerment of communities, environmental sustainability, urban and regional planning, healthy settings and chronic and communicable disease management, equity based health systems, environmental health, health security, etc. There were pre- and post-conference courses organized, and all this integrated into the '10 days Healthy City Forum'.

The IFEH was also among the sponsors of the global event and was represented by Dr Peter Davey, the President of the IFEH, Secretary of the Alliance for Healthy Cities Australian Chapter and the Chair of the Conference. Dr Andrius Kavaliunas, from Lithuanian Union of Hygienists and Epidemiologists, set up the IFEH Trade Display and had an opportunity to present his research on development public health at local level and epidemiology of food allergy.

As well as well as the opportunity to meet with famous and interesting people from various countries, like well known Evelyn de Leeuw, Agis D. Tsouros, Trevor Hancock, Shin Young-soo, the participants enjoyed Australian hospitality, including cute koalas, and had a unique opportunity to explore the country's nature, visit the famous Gold Coast and end up with bright recollections and new ideas for "healthy futures in cities and communities globally".

# New Zealand Institute of Environmental Health (NZIEH)

The NZIEH National Council Meeting was held on 26th February followed by their three day National Conference, writes Stephen Bell, President.

NZIEH Conferences move around New Zealand and this year it was held in sub tropical Whangarei. The conference was well attended, informative but more importantly relaxed.

One of the highlights was a field trip through New Zealand's only oil refinery at Marsden Point. This was followed by nibbles and drinks at the new Marsden Cove residential marina. Marsden Cove development is just inside the entrance of the Whangarei Harbour and has a 230 berth marina at its centre and is a mix of new housing and building plots for those who prefer to design their own homes. With a log port and Oil Refinery as neighbours, planning was a challenge.

The Conference dinner on the second evening not only featured a mayoral address from His Worship Morris Cutforth, Mayor of Whangarei, but also Hawaiian shirts and Cook Island dancers!

Following the conference ten of us took the opportunity to go diving in the Poor Knights Islands Marine Sanctuary. An amazing experience to see what can happen in the marine environment when humans are stopped from exploiting it.

Not all fun, sun and sea, the conference covered a range of topics from Environmental Health inequalities; control of storm water infiltration into sewage systems, bathing water quality, school food programmes, motivational interviewing, contaminated sites and new disease threats. There was something for everyone. Conference 2014 will be at Massey University in Wellington.

## World Malaria Day

This year's World Malaria day will be held on 25 April 2013 and the theme is 'Invest in the future. Defeat malaria'. Since the year 2000, malaria mortality rates have fallen by more than 25%, and 50 of the 99 countries with ongoing transmission are now on track to meet the 2015 World Health Assembly target of reducing incidence rates by more than 75%. A major upscaling of vector control interventions, together with increased access to diagnostic testing and qualityassured treatment, has been key to this progress.

However Malaria is still a major problem Worldwide killing an estimated 660,000, mainly children under five years of age in sub-Saharan Africa. Added to this over 200 million cases occur with most, but not all, of these cases never declared or tested. The current World financial problems have not helped resulting in progress slowing down. Emerging drug and insecticide resistance, according to WHO, threaten to reverse recent improvements. Clearly to maintain and accelerate progress against Malaria more funds are urgently required.
