Dr. Henroy Scarlett is an environmental public health specialist with over 38 years' experience in practicing, teaching, researching, publishing, and consulting in the fields of environmental health, public health, and occupational health. He is the holder of three degrees (Dr. PH, MPH & BHSc) in environmental health/public health, three professional diplomas in environmental/community health, the Registered Environmental Health Specialist/Registered Sanitarian (REHS/RS) — the highest credential offered by NEHA to environmental health officers in the USA. He is a Diplomate of the American Association of Sanitarians (DAAS) — highest recognition awarded to sanitarians in the USA.

For the past 17 years he has been a lecturer and course leader of the environmental health portfolio in the Faculty of Medical Sciences at the University of the West Indies (UWI), Mona and teaches on the medical undergraduate and graduate programmes in the faculty.
