Abstract and speaker biography of selected papers will be included in the Congress registration materials on our web site, as well as printed in the final program distributed at the event in San Diego.

All papers must be written in English. The following layout requirements are highly recommended:

- ✓ text should be typed with single spacing in 12 points Times Roman in an area 6 1/2 inches wide by 9 inches high
- ✓ title in 14 point with bold, capital letters
- ✓ author name underlined
- ✓ Microsoft Word or WordPerfect computer format preferred
